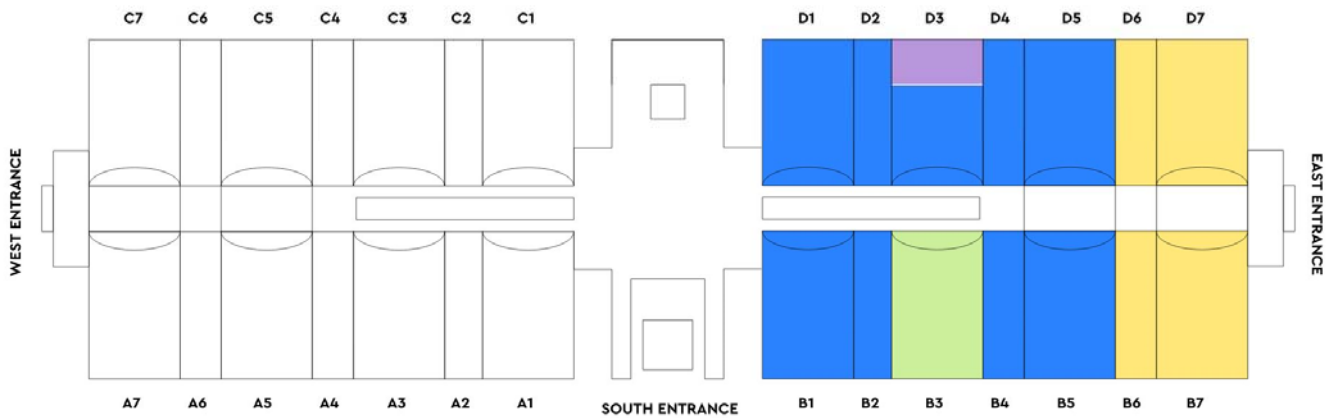
NOTICES TO EXHIBITING COMPANIES
